Arrived on site to find a blocked toilet. Provided estimates and customer wanted to proceed with an attempt to unblock with toilet auger and plunger. Set up tarps and plunged toilet line unblocked quickly. Performed partial plumbing checkup and customer stated they were having issues with floor drain backing up when laundry was used. Tested line and floor drain immediately backed up clean out is present under laundry sink. Provided new estimates and customer approved work. Used k912 out to 20' floor drain drained slowly tested line and floor drain backed up slowly. Cabled through floor drain and it drained immediately dumped 4 buckets of water down floor drain and it is draining well. Dumped 5 sinks of water and line is draining well. Appears floor drain was backing up mostly due to trap seal primer line and main blockage was in the trap arm of the floor drain.

30 day warranty on unblocking.

Performed partial plumbing checkup.
